# 33rd Annual Eastern Shore Agricultural Conference & Trade Show

The 2023 Eastern Shore Agricultural Conference and Trade Show gets better every year! We were honored to have Virginia Secretary of Agriculture Matt Lohr, Virginia Commissioner of Agriculture Joe Guthrie, and the new Virginia Cooperative Extension Director Dr. Mike Gutter attend the conference to give updates on the morning of the first day. Robert Harper from Virginia Farm Bureau gave an excellent presentation on commodity crop prices and where they are going in 2023 along with the keynote speaker, Veronica Nigh from American Farm Bureau, diving deeper into international economics and explaining the impacts on our fertilizer prices. The conference planning committee would like to thank all of our speakers for their support of Eastern Shore Farmers.

There were 31 agribusiness booths on the tradeshow floor who were able to visit with approximately 325 attendees over the two-day conference. Speakers came from throughout Virginia, Delaware, Maryland, North Carolina, and Colorado to speak to

#### General Assembly Updates

### • HB 1806 - Farm Use Placards

Delegate Bloxom has sponsored a bill in the house that would delay the requirement for vehicles claiming a farm use exemption to obtain and display a DMV placard from July 1, 2023, to January 1, 2024. He has also introduced the following details that would apply to farm vehicles:

- The bill exempts trailers and semitrailers from the requirement to display a farm use placard.
- The bill removes certain requirements on the application for a farm use placard, prohibits requesting additional information on such application, and prohibits disclosure of application information for certain purposes.
- The bill clarifies that certain farm use exemptions apply to all pickup and panel trucks, sport utility vehicles, and trailers or semitrailers, not just those having a gross vehicle weight greater than 7,500 pounds.
- The bill authorizes the use of an agricultural or horticultural vehicle for disposing of incidental refuse and a seasonal transportation vehicle for driving to a storage house, packing plant, or market regardless of distance.
- The bill clarifies that the exemption for transporting back to a farm essential food includes procuring a meal for a farmer or his employees and that such exemption applies while engaged in authorized farm vehicle uses.

We will be following this bill through the legislative process and will also organize an informational session after the legislative session that would allow for farmers to get answers to their questions. As we plan, we will keep everyone updated.

#### • Chincoteague Pony Bill - HB 1951 & SB 1478

Sophia Pearl Gallivan, a junior at Broadwater Academy, has been advocating for a piece of bipartisan legislature to make the Chincoteague Pony the official Pony of Virginia. Delegate Bloxom and Senator Lewis have submitted House Bill 1951 and Senate Bill 1478 that acknowledges the cultural, historical, and economic impacts these iconic Chincoteague Ponies have provided to the Commonwealth of Virginia.

Sophia is a member of the Chincoteague Pony Drill Team and President of Hoof Beats By the Beach 4-H club. She was recently appointed a Virginia 4-H Horse Ambassador and has been representing Virginia in Atlanta at the National 4-H conference as a delegate. Sophia has been to Richmond advocating and has received support from First Lady Youngkin. We are very proud of Sophia and all the work she has put in to lobbying for this legislation and is an excellent representative of our 4-H program here on the Shore! Way to go Sophia!

Northampton 4-H is looking for individuals who are interested in volunteering for the Real Money Real World simulation taking place on March 2, 2023 at Northampton High School. - c) Utilize landscape architectural tools to represent these solutions for use by the community.


